Dealers are required to provide a table covering and **are responsible for cleanup of their spaces. If extensive clean up of your space is required, a \$25.00 fee will be assessed and you will not be invited to our Craft Fair again.**

The Lessor, The "Bishop of Cleveland", the "Roman Catholic Diocese of Cleveland" and St. Monica Church shall not be responsible for any injury or loss that may occur to the Lessee, his employees or his goods from any cause whatsoever while said premises (St. Monica School) is being occupied by the Lessee under this agreement.

NOTE: This signed contract and check made payable to St. Monica P.T.U. must be received by **October 15, 2009.**

Reservations for space is not secure until contract and check are received. This contract only reserves a table; its location is based on availability. **CHECKS ARE NON-REFUNDABLE as long as space is available.**

St. Monica PTU Craft Fair does not permit the sale of "Flea Market" items. If the Craft Fair Committee feels that your items do not meet with our criteria, you will be asked to remove the items that we find unacceptable, or you may be asked to leave and your table fee will not be refunded.
